Minutes: The Minutes of the Annual General Meeting held on 5th May were agreed

Discussion with Attendees on Masonic Lodge Application for License Variation and New Co-op site

Miss Rhona McCalllum addressed the Council regarding the above Application . Raising points such as only neighbours with property 4 metres from the Lodge were informed by Fife Council , that there are potential issues regarding noise and parking and concerns over the extension of the licence and to include admitting non members , extended hours , providing bar meals etc .

Mr David Bayne replied for the Lodge , reporting that they were switching from an occasional license to a full licence at the advice of Fife Council , there was no intention to change to full time hours .Their intent is to give flexibility to allow them to host events/functions to meet demand .Issues of noise have been addressed. The licensing Board have inspected the venue and Council sound engineers will be attending the first event to monitor sound levels

It was asked what was the intent behind the change of licence was . Mr Bayne said for financial reasons , so events such as funerals can raise money to help keep the building going .Extra measures are in place , no parties for under 25s , except childrens parties ., they will not run an off-licence service and signage for no bottles or gasses outside. The full license has a single license holder so comes with more accountability.. Mr Bayne asked for this information be included in our Minutes .

Lesley asked if there had been any response from Fife Council to the resident petition against the resiting of the Co-oP in Queen Street .But no response so far She added that photos had been added to the application on the planning site , seemingly to make King Street look quieter and wider and photos of an unknown building . Could we speak to the Co-op .was asked .There were concerns that if a suitable new site they may close the existing one completely . It was proposed and passed that that the Co-op be invited to send a representative to our July Meeting
